BOND ORDINANCE TO AUTHORIZE THE ACQUISITION OF REAL PROPERTY, THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF ADDITIONAL AND REPLACEMENT EQUIPMENT IN AND FOR THE TOWNSHIP OF NORTH BERGEN, IN THE COUNTY OF HUDSON, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$8,980,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION IN THE AMOUNT OF \$8,531,000 AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS

#### 

THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN, in the County of Hudson, State of New Jersey, do ordain as follows:

Section 1. The acquisition of land, the making of the public improvements and the acquisition of the additional and replacement equipment described in Section 3 of this bond ordinance are hereby authorized to be acquired and made by the Township of North Bergen, in the County of Hudson, State of New Jersey (the "Township"). There is appropriated to the acquisition of land, the acquisition of additional and replacement equipment and the making of the improvements described in Section 3 hereof (hereinafter referred to as "purposes") the respective amounts of money hereinafter stated as the appropriations for said respective purposes. Such appropriations shall be financed from the proceeds of the sale of the bonds authorized herein and the down payment authorized and appropriated by this bond ordinance.

Section 2. The Board of Commissioners of the Township has ascertained and hereby determines that (1) none of the purposes referred to in the schedule set forth in Section 3 of this bond ordinance is a current expense of the Township, and (2) it is necessary to finance said purposes by the issuance of obligations of the Township pursuant to the Local Bond Law of New Jersey, and (3) each of said purposes shall be undertaken as a general improvement, no part of which shall be assessed against property specially benefited.

Section 3. The several purposes herein authorized for the financing for which said obligations are to be issued, are set forth in the following "Schedule of Improvements, Purposes and

Amounts", which schedule also shows (1) the estimated cost of each such purpose, and (2) the amount of each such sum which is to be provided by the down payment hereinafter appropriated to finance the respective purposes, and (3) the estimated maximum amount of bonds and notes to be issued for each such purpose, and (4) the period of usefulness of each such purpose, according to its reasonable life, computed from the date of such bonds:

Said improvements shall be undertaken pursuant to the plans, drawings and profiles for the following locations, including substitutions or additions to such locations as may be made subsequent hereto upon filing of such changes, and that shall all be filed in the offices of the Township Engineer, the Township Clerk, and Chief Financial Officer and shall include, without limitation, the following areas in the Township:

40th – 91st Streets between Dell Avenue and Boulevard East, and 6th - 39th Streets between Kennedy Boulevard and Liberty Avenue

Said improvements shall be made in accordance with plans, drawings and specifications for the following buildings and shall include additions and substitutions, that shall all be filed in the offices of the Township Engineer, Township Clerk and Chief Financial Officer:

A list of such equipment to be acquired shall be filed in the offices of the Chief Financial Officer and the Township Clerk and may be amended by subsequent filings.

Section 4. For the improvement or purpose described in Section 3, there is hereby appropriated the aggregate amount of \$449,000 as the down payments required by the Local Bond Law. The down payments are now available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 5. The costs of such purposes, as hereinbefore stated includes the aggregate amount of \$150,000 which is estimated to be necessary to finance the cost of such purposes,

including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses including interest on such obligations to the extent permitted by Section N.J.S.A. 40A:2-20 of the Local Bond Law.

Section 6. To finance the purposes, bonds of the Township of an aggregate principal amount not exceeding \$8,531,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate or rates per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this bond ordinance shall be determined by resolutions to be hereafter adopted.

Section 7. To finance the purposes, bond anticipation notes of the Township of an aggregate principal amount not exceeding \$8,531,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this bond ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this bond ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 8. Each bond anticipation note issued pursuant to this bond ordinance shall be dated on or about the date of its issuance and shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within the limitations prescribed by the Local Bond Law. Each of said notes shall be signed by the Mayor, the Director of Revenue and Finance and the Chief Financial Officer of the Township and shall be under the seal of said Township and attested by the Township Clerk. Said officers are hereby authorized to execute said notes and to issue said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this bond ordinance and also the power to sell said notes is hereby delegated to the Director of Revenue and Finance or the Chief Financial Officer who are each authorized to sell said notes either at one time or from time to time in the manner provided by law. Section 9. It is hereby determined and declared that the average period of usefulness of the purposes, according to their reasonable lives, taking into consideration the respective amount of bonds or notes to be issued for said purposes, is a period of 16.22 years computed from the date of said bonds.

Section 10. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Township Clerk of the Township, and that such statement so filed shows that the gross debt of the Township, as defined in Section 40A:2-43 of the Local Bond Law is increased by this bond ordinance by \$8,531,000 and that the issuance of the bonds and notes authorized by this bond ordinance will be within all debt limitations as prescribed by the Local Bond Law.

Section 11. The Township hereby declares the intent of the Township to issue the bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3(a) of this bond ordinance. This Section 11 is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.

Section 12. Any funds received from the State of New Jersey, or the County of Hudson or any of their agencies or any funds received from the United States of America or any of its agencies in aid of the purposes shall be applied to the payment of the cost of the purposes, or, if bond anticipation notes have been issued, to the payment of bond anticipation notes, and the amount of bonds authorized for the purposes shall be reduced accordingly.

Section 13. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 14. The Township intends to issue the obligations authorized by this bond ordinance to finance the cost of each such purposes described in Section 3 hereof. The Township covenants for the benefit of the holders of the obligations authorized herein that it will not make any use of (a) the proceeds of such obligations, any funds reasonably expected to be used to pay the principal of or interest on such obligations or any other funds of the Township, and (b) the facilities or purposes financed with the proceeds of such obligations, which would cause the interest on such obligations to become subject to Federal income taxation under the Internal Revenue Code of 1986, as amended (the "Code"), (except for the alternative minimum tax imposed on corporations by Section 55 of the Code) or subject the Township to any penalties under Section 148 of the Code, and that it will not take any action or omit to take any action with respect to such obligations, the proceeds thereof or any facilities financed thereby if such action or omission would cause the interest on such obligations to become subject to Federal income taxation under the Code (except for the alternative minimum tax imposed on corporations by Section 55 of the Code) or subject the Township to any penalties under Section 148 of the Code. The foregoing covenants shall remain in full force and effect notwithstanding the defeasance of the obligations authorized herein or any other provision hereof until the date which is sixty (60) days after the final maturity date or earlier prior redemption date thereof. The Town hereby declares its official intent to reimburse itself from the proceeds of the bonds or notes authorized by this resolution pursuant to IRS Regulation Section 1.150-2(c), promulgated under the Code, for "original expenditures", as defined in said Regulation, made by the Township prior to the issuance of such bonds or notes. Such "original expenditures" shall not exceed the sum of \$8,980,000 in the aggregate and shall be paid from funds temporarily available from the Township's current funds.

Section 15. The Township hereby covenants for the benefit of holders of obligations authorized herein to comply with Rule 15c2-12 of the Securities Exchange Act of 1934, as amended

(the "Rule"), unless an exemption from the Rule exists as provided in paragraph (d) of the Rule.

Section 16. This bond ordinance shall take effect twenty days after the first publication thereof after final passage.

# AN ORDINANCE ESTABLISHING A RESTRICTED PARKING SPACE FOR USE BY THE HANDICAPPED

Eleftherios Sekkas 714 – 85<sup>th</sup> Sreet North Bergen, NJ 07047

WHEREAS, the Commissioners of the Township of North Bergen recognize that handicapped drivers face unique difficulties in the location of parking spaces; and

WHEREAS, the Commissioners of the Township of North Bergen have been empowered by

N.J.S.A. 39:4-205 to restrict certain areas for handicapped parking; and

WHEREAS, Ordinance No. 503-93, Ordinance No. 1115-07, Ordinance No. 40-10 and Ordinance No. 203-13 establish the terms and conditions for handicapped spaces.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of North Bergen that:

Section I: One restricted handicapped parking space be and hereby is established in front of the residence of Eleftherios Sekkas of 714 – 85<sup>th</sup> Street, North Bergen, N.J. 07047.

Section 2: The aforesaid space shall be used only by a motor vehicle displaying a permit issued by the North Bergen Police Department identifying the location of said handicapped parking space and the specific motor vehicle entitled to use same.

Section 3: The North Bergen Department of Public Works shall establish a restricted parking zone at the above location and shall erect a sign with the legend "Handicapped Parking for Resident Vehicle License Plate Number "G 6 9 G P Z" for Eleftherios Sekkas, and this Ordinance Number.

Section 4: This ordinance shall remain in effect for two (2) years ending December  $31^{st}$  of the second year from its effective date at which point it will expire and be of no further force or effect unless it is renewed for a further two (2) year period by formal resolution of the Board of Commissioners in accordance with Ordinance Nos. 1115-07 and 40-10.

Section 5: Any person who commits a violation of this ordinance shall be subject to a fine of at least \$300.00 and up to 90 days of Community Service on such terms and in such form as the Municipal Court Judge deems appropriate or any combination thereof. A separate offense shall be deemed committed on each day during or on which the violation continues.

Section 6: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the inconsistency thereof.

Section 7: If any part or parts of this ordinance are for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this ordinance.

#### AN ORDINANCE AMENDING HIRING PRACTICES FOR ENTRY-LEVEL LAW ENFORCEMENT OFFICERS

# BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN that:

#### Section 1. <u>Background and Purposes</u>

- A. The hiring practices of the Township of North Bergen ("Township") are governed by the New Jersey Civil Service Act, N.J.S.A. 11A:1.1, et seq., and Title 4A of the New Jersey Administrative Code.
- B. On February 4, 2021, Governor Murphy signed into law N.J.S.A. 11A:4-1.3 (P.L. 2021, Chapter 7), which amended the Civil Service Act, N.J.S.A. 11A:1-1, et seq.
- C. On January 18, 2022, N.J.S.A. 11A:4-1.3 was amended by P.L. 2021, c. 406.
- D. These new laws permit municipalities to hire entry level police officers who have not taken the civil service law enforcement examination, but who are otherwise duly qualified.

E. Under the new laws, hiring authorities will be permitted to appoint law enforcement officer candidates who successfully completed a full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training Commission, or who successfully complete said course within nine months from the date of hire as a temporary entry level officer under the provisions of N.J.S.A. 11A:4-1.3.

- F. The Township and North Bergen Police Department are in compliance with the new laws' requirement to have adopted conflict of interest and nepotism policies.
- G. The Township wishes to enact this new police officer hiring option for the health and safety of its residents, to fill critical positions, and to further enhance the North Bergen Police Department's already existing and extensive diversity.

#### Section 2. <u>Exemption from Law Enforcement Examination for Entry-Level Police</u> Officers

- A. The Township, acting through the appropriate appointing authority, is authorized pursuant to N.J.S.A. 11A:4-1.3 to hire as entry-level law enforcement officers (1) persons who have successfully completed a full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training Commission, and (2) persons who successfully complete said course within nine months from the date of hire as a temporary entry level officer, provided such persons are otherwise qualified to serve as a police officer.
- B. A person hired pursuant to Subsection 2.A above shall be exempt from the requirement to take the Civil Service law enforcement examination for an entry-level law enforcement officer positions.

#### Section 3. <u>Repealer</u>

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed as to the inconsistency thereof.

# AN ORDINANCE FORMING THE GREEN ENVIRONMENTAL ADVISORY COMMITTEE

# BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN that:

#### Section 1. Background

A. The Township of North Bergen recognizes that climate change is a challenge facing people, and that the Township may be able to undertake reasonable steps to help minimize climate change.

B. There have been several suggestions that have been and continue to be brought to the Township for evaluation and possible implementation with respect to environmental issues and climate change. These include energy aggregation through the use of renewable energy sources, composting centers, community gardening, and energy efficient equipment upgrades.

C. The evaluation and research of environmental and green initiatives and programs that may help minimize climate change and otherwise improve the environment is best served by an advisory committee consisting of members with expertise or interest in these initiatives and programs. Through such a committee, initiatives and programs may be researched and evaluated, with certain programs being submitted to the Township for formal consideration and possible implementation.

# Section 2. <u>Green Environmental Advisory Committee</u>

A. The Green Environmental Advisory Committee is hereby formed, and it shall consist of nine (9) members. The members shall be residents of the Township. The term of said members shall be for one (1) year, except that members first appointed to the Green Environmental Advisory Committee after the Committee's creation shall serve through December 31<sup>st</sup> of the year of their appointment. The members shall be appointed by the Mayor with the advice and consent of the Board of Commissioners. Should there be a vacancy, the vacancy shall be filled for the unexpired term only. There shall also be a Secretary to the Green Environmental Advisory Committee, who shall be appointed by the Mayor with the advice and consent of the Board of Commissioners. The Secretary's term shall be the same as that of the members.

B. The powers and duties of the Green Environmental Advisory Committee shall be as follows:

1. To select a Chairperson, who shall preside over the meetings of the Green Environmental Advisory Committee and who shall preform such other duties as set forth herein;

2. To hold regularly scheduled monthly meetings whenever necessary to evaluate environmental ideas, initiatives and programs, as well as hold any additional special meetings as the Chairperson, in consultation with the Township Administrator, deem necessary to effectuate the purposes of this Ordinance;

3. To research and investigate green environmental ideas, initiatives and programs which may be appropriate for implementation by the Township;

4. To receive from the public or Township Departments or agencies green environmental ideas, initiatives, programs and information that may be appropriate for implementation by the Township;

5. To collaborate with any members of the public concerning green environmental ideas, initiatives, programs and information that may be appropriate for implementation by the Township;

6. To evaluate the costs, benefits and impacts on North Bergen residents of any green environmental ideas, initiatives and programs under consideration;

7. To collaborate and consult with the Township Administrator about the forgoing;

8. With prior permission of the Township Administrator, to engage Township employees, professionals and consultants where necessary to research, investigate and implement green environmental ideas, initiatives and programs;

9. To make recommendations to the Township Board of Commissioners, either directly or through the Township Administrator, for consideration and possible implementation by the Township;

10. To adopt rules and regulations concerning the operations of the Green Environmental Advisory Committee and the conduct of its meetings; and

11. To take such other actions as may be necessary, convenient or desirable for the Green Environmental Advisory Committee to fulfill its role as set forth in this Ordinance.

# Section 3. Open Public Meeting Act

The Green Environmental Advisory Committee will not have the power to adopt ordinances, will not have the power to expend public funds without further approval or authorization by the Township, and will not have the power to implement any Township initiatives or programs using public funds or affecting persons' rights without Township approval. Accordingly, the Committee shall not be subject to the Open Public Meetings Act.

# Section 4. <u>Payments to Committee Members</u>

A. The Township shall make payments to the Green Environmental Committee Chairperson and members in the following amounts:

- 1. Chairperson: \$ 83.33 per regular and special meeting attended;
- 2. Member: \$ 62.50 per regular and special meeting attended.
- B. The annual payment to the secretary to the Committee shall be \$1,000.

# Section 5. <u>Repealer</u>

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed as to the inconsistency thereof.

# Section 6. <u>Severability</u>

If any article, section, sub-section, sentence, clause, or phrase of this Ordinance is for any reason deemed to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

# Section 7. <u>Effective Date</u>

This Ordinance shall take effect 20 days from the time of its final passage.
