

WHEREAS, in September 2019, the Township of North Bergen adopted an ordinance providing rules and regulations, a form of permit application and a form of agreement for road openings and right of way occupancies in the Township of North Bergen; and

WHEREAS, the Federal Telecommunications Act preserves local government's ability to manage the public rights of way on a competitively neutral and non-discriminatory basis, 47 U.S.C. 332 (c)(7)(A); and

WHEREAS, New Jersey municipalities must give consent before a small cell antenna can be placed on existing poles pursuant to N.J.S.A. 48:3-19 and for the erection of new poles within the public right of way pursuant to N.J.S.A. 48:17-10; and

WHEREAS, on September 27, 2018, the Federal Communications Commission ("FCC") adopted an order entitled "Accelerating Wireless Broadband Deployment by Removing Barriers to Infrastructure Investment; Accelerating Wireline Broadband Deployment by Removing Barriers to Infrastructure Investment" (the "FCC Order") WT Docket No. 17-79; WC Docket 17-84, which places a shot clock on municipal approval for the placement of small cell antennas on existing poles and the placement of new poles in the municipal right of way, and limits the ability of municipalities to restrict the installation of small cell antenna facilities in the public right of way; and

WHEREAS, Cross River Fiber LLC seeks to install 25 small cell antennas and related equipment, with four (4) antennas being on existing poles or replacement poles and 21 being on new poles at new locations; and

WHEREAS, a proposed Right of Way Agreement providing for the installation and maintenance of the small cell antennas and related equipment is on file in the Township Clerk's office, and

WHEREAS, pursuant to the Agreement, which has a 15 year term, Cross River Fiber must apply for and receive all necessary permits and approvals prior to installing the poles and small cell antennas and related equipment.

ORDINANCE TO INCREASE THE MUNICIPAL BUDGET
CAP RATE AND TO ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)**

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 1.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and the Board of Commissioners of the Township of North Bergen in the County of Hudson finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Mayor and the Board of Commissioners hereby determines that a 3.5% increase in the budget for said year, amounting to \$2,501,603.40 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Mayor and the Board of Commissioners hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and the Board of Commissioners of the Township of North Bergen, in the County of Hudson, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Township of North Bergen shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$2,501,603.40, and that the CY 2021 municipal budget for the Township of North Bergen be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.





**AN ORDINANCE APPROVING A FIVE (5) YEAR TAX EXEMPTION
PURSUANT TO THE PROVISIONS OF N.J.S.A. 40A:21-1, ET SEQ.,
FOR PROPERTY DESIGNATED AS BLOCK 224, LOT 21.01 ON THE
TOWNSHIP'S TAX MAP AND MORE COMMONLY KNOWN BY THE
STREET ADDRESS OF 6723 KENNEDY BOULEVARD (aka 6701 KENNEDY
BOULEVARD), NORTH BERGEN, NEW JERSEY**

WHEREAS, pursuant to N.J.S.A. 40A:21-1 et seq., the Township of North Bergen adopted Ordinance 467-20 to allow Five (5) Year Tax Exemptions which allows the Tax Assessor to regard the full and true value or a portion thereof of certain improvements as not increasing the full and true value of certain property for a period of five (5) years, provided the owner's application is approved by the Tax Assessor and by Ordinance of the Board of Commissioners; and

WHEREAS, pursuant to N.J.S.A. 40A:21-1, et seq., and Ordinance 467-20, a tax exemption for a new mixed use structure consisting of three retail stores and 51 residential units, is permitted for a period of five (5) years; and

WHEREAS, 67th St & Kennedy Blvd West, LLC is the owner of a new mixed use structure consisting of three retail stores and 51 residential units, located in Block 224, Lot 21.01 on the Township's Tax Map and more commonly known by the street address of 6723 Kennedy Boulevard (aka 6701 Kennedy Boulevard), Township of North Bergen; and

WHEREAS, on March 8, 2021, the owner filed an application to tax exempt the mixed use structure consisting of three retail stores and 51 residential units, a copy of which application is incorporated herein by reference; and

WHEREAS, 67th St & Kennedy Blvd West, LLC proposes to pay the Township (in addition to the full taxes on the land, which shall continue to be conventionally assessed and taxed) a tax payment for the new improvements on the property, as follows:

1. 2021 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
2. 2022 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
3. 2023 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
4. 2024 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.

5. 2025 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.

WHEREAS, the application for tax exemption was complete and timely filed; the application was approved by the Tax Assessor and the mixed use structure with three retail stores and 51 residential units is eligible for tax exemption pursuant to N.J.S.A. 40A:21-9 and Ordinance No. 1135-08; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Township of North Bergen that:

Section 1

1. The application, incorporated herein by reference, for a five (5) year tax exemption for the full and true value of new three retail stores and 51 residential units, located in Block 224, Lot 21.01 on the Township's Tax Map and more commonly known by the street address of 6723 Kennedy Boulevard (aka 6701 Kennedy Boulevard), Township of North Bergen, is hereby approved.

2. The Mayor or Township Administrator is hereby authorized to execute a tax exemption agreement which shall contain at a minimum, the following terms and conditions:

- (a) tax payment on the new improvements shall be;
 1. 2021 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
 2. 2022 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
 3. 2023 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
 4. 2024 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
 5. 2025 - \$180,000.00 - Payment shall be paid quarterly in the amount of \$45,000.00 on February 1st, May 1st, August 1st and November 1st.
- (b) The project shall be subject to all federal, state and local laws; and regulations on pollution control, worker safety, discrimination in employment, zoning, planning, and building code requirements pursuant to N.J.S.A. 40A:21-11(b).
- (c) If during any tax year prior to the termination of the tax agreement, the property owner ceases to operate or disposes of the property; or fails to meet the conditions

for qualifying, then the tax which would have otherwise been payable for that tax year, but not previous years, shall become due and payable from the property owner as if no exemption and abatement had been granted. The collector forthwith and the tax collector shall, within 15 days thereof, notify the owner of the property of the amount of taxes due.

- (d) With respect to the disposal of the property, where it is determined that the new owner of the property will continue to use the property pursuant to the conditions which qualified the property; no tax shall be due, the exemption shall continue and the agreement shall remain in effect.
- (e) At the termination of a tax exemption agreement, the new improvements shall be subject to all applicable real property taxes as provided by State law and regulation and local ordinance; but nothing herein shall prohibit a project, at the termination of an agreement, from qualifying for, and receiving the full benefits of, any other tax preferences provided by law.
- (f) Nothing contained in the application for Tax Abatement shall bind the Township in any manner from establishing the tax assessment for the property at the expiration of the Tax Agreement. The Tax Assessor can take into consideration the configuration of the site and then current income and expense statements to establish the tax assessment.

3. The form of tax exemption agreement is on file in the Township Clerk's office, subject to such modification as the Township Attorney or Township Administrator deems necessary.

4. The Township Administrator shall send a copy of the fully executed Tax Agreement to the Director of the Division of Local Government Services in the Department of Community Affairs within thirty (30) days of execution pursuant to N.J.S.A. 40a:21-11(d).

Section 2

All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

Section 3

This ordinance shall take effect at the time and in the manner provided by law.



AN ORDINANCE AMENDING THE TOWNSHIP OF NORTH BERGEN'S RENT CONTROL ORDINANCE TO EXTEND THE MORATORIUM ON RENT INCREASES UPON RENT-CONTROLLED PROPERTIES DURING THE COVID-19 PANDEMIC.

BE IT ORDAINED BY THE COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN, as follows:

Section 1. Background

A. By Township of North Bergen Ordinance No. 467-93, as amended, the Township regulates, controls and stabilizes rents under its police powers in order to protect the health, safety and welfare of the citizens of the Township.

B. Due to the Covid-19 pandemic, the Township further amended Ordinance 467-93 by enacting Ordinances 463-20, 469-20, 477-20, 489-20, and 499-21, which together imposed a temporary moratorium on rental increases on Rent Controlled Dwellings until the earlier of the following: The end of the Covid-19 State of Emergency declared by the Governor of the State of New Jersey on March 9, 2020 (Executive Order 103) or by April 30, 2021.

C. The Township has determined that the continuing Covid-19 pandemic requires an extension of the temporary moratorium on rental increases.

D. The Township Board of Commissioners also finds that this Ordinance should take effect immediately upon final adoption, and that the 20-day waiting period pursuant N.J.S.A. 40:74-4 should not apply because this Ordinance's immediate enactment is necessary for the immediate preservation of the public peace, health and safety of North Bergen's residents.

Section 2: Rent Increase Moratorium Extended

Ordinances 463-20, 469-20, 477-20, 489-20, and 499-21 are amended to replace Section 2, Paragraph D with the following language:

D. "Moratorium Period" shall begin upon final adoption of Ordinance 463-20, which was May 13, 2020, and continue until the earlier of the following:

1. The end of the Covid-19 State of Emergency declared by the Governor of the State of New Jersey on March 9, 2020 (Executive Order 103);
or
2. June 30, 2021.

Section 3. Penalties

The penalty and violation provisions set forth in the Rent Control Ordinance 467-93 are applicable for any violations of this Ordinance.

Section 4. Repealer

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed as to the inconsistency thereof.

Section 5. Liberal Construction

This Ordinance, being necessary for the welfare of the Township residents, shall be liberally construed to effectuate its purposes.

Section 6. Severability

If any part or parts of this Ordinance are for any reason held to be invalid, such invalidity shall not affect the validity of the remaining portions of this Ordinance.

Section 7. Effective Date

This Ordinance shall take effect immediately upon final adoption.


