TOWNSHIP OF NORTH BERGEN COUNTY OF HUDSON

AN ORDINANCE PROHIBITING SHORT TERM RENTALS OF RESIDENTIAL PROPERTIES AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF WITHIN THE TOWNSHIP OF NORTH BERGEN

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN as follows:

Section 1. Background and Findings.

- A. The Township of North Bergen ("Township") finds that the rental of residential dwellings for short-term occupancy has been identified as a community concern due to the potential for increased traffic, noise, high occupant turnover, and increased density in residential neighborhoods.
- B. The number of individuals occupying such short-term rentals has the potential to exceed standards for the design capacity of such structures and to cause health and safety risks for the occupants, neighbors and nearby properties.
- C. The purpose of this Ordinance is to safeguard the peace, safety and general welfare of the residents of the Township and their visitors and guests by eliminating noise, traffic and parking congestion, vandalism, overcrowding, neighborhood uncertainty, high occupant turnover, diminution of neighborhood character, and other secondary effects that have been associated with the short-term rental of residential properties.
- D. The short-term rental market nationwide has expanded with the use of professional brokers and internet listing services. This increase requires an expansion of enforcement mechanisms to deter parties who facilitate and solicit short term rentals. Because there are numerous homeowners, real estate offices, brokers, and other agencies that actively promote short-term rentals to potential Township visitors through the internet and other forms of advertisement, it is necessary to prohibit the promotion and advertisement of short-term rentals.
- E. Therefore, the Township adopts the following provisions in order to prohibit short-term residential rentals, and enforce said prohibitions.

Section 2. Definitions.

For the purpose of this Ordinance, the following definitions shall apply unless the context clearly indicates or requires a different meaning:

- A. Advertise or Advertisement: Any written, electronic or oral publication, dissemination, solicitation or circulation which is intended to directly or indirectly induce any person to enter into an agreement for the short-term rental of a dwelling. This definition includes but is not limited to mailings, print advertisements, internet listings, e-mail publications or other oral, printed or electronic media.
- B. Dwelling: Any single or multi-family residential building or structure in the Township, or any part thereof, which is occupied in whole or in part, or intended to be occupied in whole or in part, as a home, residence or sleeping place for one or more individuals.

- C. Facilitate: A person "facilitates" if, acting with knowledge that an operator, managing agency or rental agent is renting a dwelling on a short-term basis, the person knowingly provides the operator, managing agency or rental agent with means or opportunity for the commission of said offense.
- D. Person: An individual, corporation, association, firm, partnership, limited liability company, or other legal entity.
- E. Rent: The consideration or remuneration charged, whether or not received, for the occupancy or use of a dwelling, whether to be received in money, goods, services, labor, other use of other dwelling(s), or otherwise.
- F. Rental: An agreement between persons whereby rent is charged in exchange for the right to occupy or use a dwelling.
- G. Short-term rental: Any rental of a dwelling for less than 30 consecutive days.
- H. Solicit: A person "solicits" if, with the intent to promote or facilitate the short-term rental of a dwelling, such person commands, encourages, requests or solicits another person to engage in a short term rental agreement.

Section 3. Prohibited Conduct.

- A. No person shall use, possess or occupy a dwelling on a short-term rental basis.
- B No person shall enter a short-term rental agreement for a dwelling.
- C. No person owning, leasing, or having control of a dwelling shall allow it to be used, occupied or possessed as a short term rental.
- D. No person shall advertise, solicit or facilitate a short-term rental agreement for a dwelling.

Section 5. Violations and Penalties.

- A. Any person who violates any provision of this Ordinance shall be fined as follows:
 - 1. For a first violation a fine of \$750.00 per day for each violation for each dwelling unit and/or ten (10) days in jail at the discretion of the Municipal Court Judge, or both;
 - 2. For a second violation a fine of not less than \$750 and not more than \$1,200 per day for each violation for each dwelling unit and/or twenty (20) days in jail at the discretion of the Municipal Court Judge, or both;
 - 3. For a third or subsequent violation a fine of not less than \$1,200.00 and not more than \$2,500.00 per day for each violation for each dwelling unit and/or thirty (30) days in jail at the discretion of the Municipal Court Judge; or both.

Each day that a person violates a provision of this Ordinance shall be considered as a separate and distinct violation.

Section 6. Enforceability.

This Ordinance may be enforced by North Bergen Building Department Inspectors, North Bergen Fire Prevention Inspectors, and North Bergen Housing Inspectors

together with any other municipal officials authorized to enforce Township Ordinances.

Section 7. Severability.

If any article, section, sub-section, sentence, clause, or phrase of this Ordinance is for any reason deemed to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 8. Effect.

This Ordinance will take effect upon publication as required by law.

COMMERICAL VEHICLE PARKING ORDINANCE

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN that:

Section 1: Definition:

For purposes of this Ordinance, the term "commercial vehicle" shall mean a vehicle used for the transportation of persons for hire, compensation or profit, or designed or used for the transportation of property, materials, cargo, equipment or tools. The term commercial vehicle shall include, but not be limited to, commuter vans, food vending trucks, limousines, recreational vehicles, motor drawn vehicles, omnibuses, panel vans, pole trailers, road tractors, school buses, semi-trailers, taxicabs, tow trucks, trucks, and truck tractors, vehicles having more than 4 wheels, vehicles weighing more than 9,000 lbs., vehicles having a height in excess of 9.5 feet, vehicles having a length of more than 18 feet, vehicles having a width of more that 7 feet, vehicles having tool, cargo or equipment racks or cages in the interior or on the exterior of the vehicle, vehicles containing commercial or business lettering, advertising or graphics, and vehicles registered as commercial, omnibus, limousine, livery, taxi, farmer, commuter van, or school vehicle.

Section 2: Parking of Commercial Vehicles Prohibited In Residential Neighborhoods:

Except as provided in Section 4 of this Ordinance, no person shall park or leave standing a commercial vehicle upon any front yard, side yard, rear yard, or any other private driveway or parking lot, where that vehicle is visible from the street in an R1, R2, R3, P1, or P2 residential zone.

Section 3: Parking of Commercial Vehicles In All Neighborhoods:

Except as provided in Section 4 of this Ordinance, no person shall park or leave standing a commercial vehicle, upon any street, public land, avenue, road, or other public thoroughfare in the Township of North Bergen. This Ordinance shall not apply to commercial industrial zones.

Section 4: Exceptions to Prohibition of Commercial Vehicles:

- A. The prohibition as to commercial vehicles parking in areas provided for in Section 2 and Section 3 shall not apply to commercial vehicles that are in the process of rendering services to premises within said neighborhoods.
- B. A property that is the subject of a variance for business purposes or a pre-existing, non-conforming business use shall not be deemed to be in an R1, R2, R3, P1 or P2 residential zone.
- C. Rental moving trucks, utilized while under a rental agreement, shall be permitted to be parked for a continuous 72 hour time period.
- D. The prohibition as to commercial vehicles parking in areas provided for in Section 2 and Section 3 shall not apply to commercial vehicles, where the vehicle owner has obtained a valid residential parking permit from the North Bergen Parking Authority ("Parking Authority") pursuant to Section 5 of this Ordinance.

Section 5: Obtaining a Residential Parking Permit

- A. The owner of a vehicle falling within the definition of commercial vehicle set forth in Section 1, may obtain a residential parking permit for a passenger van, panel van, or pickup truck, provided:
- 1. the vehicle is not, and will not be, used for any business or commercial purpose, and the vehicle owner certifies to this fact;

- 2. the vehicle does not contain any tool, cargo or equipment racks or cages, either in the interior or on the exterior of the vehicle;
- 3. the vehicle does not contain any commercial or business lettering, advertising or graphics;
- 4. the vehicle is not registered as a commercial vehicle, omnibus, limousine, livery, taxi, farmer vehicle, commuter van, or school vehicle;
- 5. the vehicle does not weigh more than 9,000 lbs;
- 6. the vehicle owner does not have another non-commercial vehicle registered in his name, or another commercial vehicle having a residential parking permit; and
- 7. with respect to a passenger van, the van does not contain more than three rows of seats, including the front seats.
- B. After having obtained a residential parking permit for a commercial vehicle pursuant to this Section, no person shall do any of the following without first having returned their residential parking permit to the Parking Authority:
- Change, modify or alter their permitted vehicle so that it no longer would qualify for a residential parking permit under this Section;
 or
- 2. Use their permitted vehicle, or allow the use of their permitted vehicle, for the transportation of persons for hire, for compensation or profit, or for the transportation of property, materials, cargo, equipment or tools, or for any other commercial or business related purpose.

- C. The Parking Authority may revoke a residential parking permit issued for a commercial vehicle for any violation of Section 5.B.
- D. The determination of whether a commercial vehicle qualifies for a residential parking permit, or whether a residential parking permit should be revoked, shall be within the exclusive discretion of the Parking Authority, based on the criteria set forth in this Section.

Section 6. Enforcement

The Parking Authority shall have and exercise the power and perform the duties associated with the management, operation and enforcement of this Ordinance. The North Bergen Police Department shall also enforce the provisions of this Ordinance.

Section 7: Penalties and Fines

- A. Commercial vehicles parked in violation of this Ordinance shall be subject to a fine of \$115.00, for the first offense, \$180.00 for a second offense and \$250.00 for a third offense. A court appearance is mandatory for a third offense. The Parking Authority shall receive a 35% share of the fines paid pursuant to this subsection 7.A.
- B. Any person violating Section 5.B of this Ordinance shall be subject to a fine of \$1,000 for each offense.
- C. Any person who falsely represents himself, herself, or their vehicle as eligible for a residential parking permit, or who furnishes false information on an application for such a permit, shall be subject to a fine of \$1,000.00 for each offense.
- D. Any person holding a residential parking permit, issued pursuant to this Ordinance, who permits or allows the use or display of such parking permit

on any motor vehicle, other than that for which the permit was issued, shall be subject to a fine of \$1,000.00 for each offense.

E. Any person who copies, reproduces or otherwise brings into existence, a facsimile or counterfeit residential parking permit, or allows another person to copy, reproduce or otherwise bring into existence a facsimile or counterfeit residential parking permit shall be subject to a fine of \$1,000.00 for each such offense.

Section 8: Severability:

If any part or parts of this Ordinance are for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 9: Consistency:

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed as to the inconsistency thereof.

Section 10: Repealer:

This Ordinance supersedes, replaces and repeals Ordinance No. 215-15.

Section 11: Effective Date:

This Ordinance shall take effect immediately upon passage and publication as required by law.
