AN ORDINANCE AUTHORIZING THE ACQUISITION OF REAL PROPERTIES FOR PUBLIC PURPOSES

WHEREAS, the Township of North Bergen wishes to obtain title to the real property known and designated as 143 74th Street and 7314 Broadway and more particularly described 0.574 acres in Block 305, Lot 44 (143 74th Street) and 0.0275 in Block 305, Lot 52 (7314 Broadway) on the Tax Map of the Township of North Bergen; and

WHEREAS, these properties are presently owned by Dorothea M. Lang Trust; and

WHEREAS, the Township of North Bergen desires to utilize these site as a parking area; and

WHEREAS, the Dorothea M. Lang Trust desires to convey these properties to the Township of North Bergen at a cost of \$290,000 for the property known as 143 74th Street and \$79,900 for the property known as 7314 Broadway; and

AN ORDINANCE TO AUTHORIZE THE ACQUISITION OF PRIVATE PROPERTY LOCATED AT 1135 43rd STREET, FOR PUBLIC PURPOSES AND AUTHORIZING THE COMMENCEMENT OF EMINENT DOMAIN PROCEEDINGS.

WHEREAS, the Township of North Bergen wishes to obtain the private property at 1135 43rd Street, also known as Block 140, Lot 35, which is necessary for public purposes; and

WHEREAS, the Township has engaged an appraiser and has/will make an offer to the property owner for the purchase of the aforesaid property, in accordance with statutory requirements; and

WHEREAS, by separate funding devices, the Township has/will appropriate the sum of One Hundred Five Thousand Dollars (\$105,000) for Block 140, Lot 35, which represents the estimated compensation for the acquisition; and

WHEREAS, in the event the offer of compensation is not acceptable, it will be necessary for the Township to initiate condemnation proceedings.

NOW, THEREFORE, be it ordained by the Board of Commissioners of the Township of North Bergen that:

Section 1. The Board of Commissioners does hereby determine that it is necessary to acquire the properties located at 1135 43rd Street, also known as Block 140, Lot 35, for public purposes.

<u>Section 2.</u> The Township hereby authorizes the acquisition of the property known as 1135 43rd Street, also known as Block 140, Lot 35 by condemnation for the purpose of acquiring approximately 2,125 square feet of private property.

<u>Section 3.</u> The Township is hereby authorized to institute proceedings pursuant to the provisions of the Eminent Domain Act, <u>N.J.S.A.</u> 20:3-1, <u>et seq.</u>, for the purposes of acquiring title to the land described herein as Block 140, Lot 35.

<u>Section 4.</u> The estimated One Hundred Five Thousand Dollars (\$105,000) compensation to be paid for the acquisition of the property as described herein is available by virtue of a separate funding or within the budget adopted by the Township. institute condemnation proceedings and seek a determination by the Court that the Township is duly empowered with the authority to acquire the land herein described for public purposes.

Section 6. If any article, section, sub-section, sentence, clause, or phrase of this ordinance is for any reason deemed to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

<u>Section 7.</u> All other parts, portions and provisions of the North Bergen Code be and the same are hereby ratified and confirmed, except where inconsistent with the terms hereof. In the event of any such inconsistency, the terms of this ordinance shall be deemed to govern.

WHEREAS, the Board of Commissioners wish to address said categories of handicapped parking spaces and to provide for the orderly control and monitoring of handicapped parking spaces established in the future.
