AN ORDINANCE PROVIDING FOR THE CREATION, ESTABLISHMENT, AND REGULATIONS OF THE NORTH BERGEN POLICE DEPARTMENT AND THE POWERS AND DUTIES OF THE NORTH BERGEN CHIEF OF POLICE

WHEREAS, the North Bergen Police Department was established by ordinance adopted on December 20, 1923; and

WHEREAS, said ordinance has been amended and modified from time to time; and

WHEREAS, it is now appropriate to bring the subject matter of that ordinance current with modern statutory requirements including but not limited to N.J.S.A. 40A:14-118.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NORTH BERGEN that:

- Section 1. The establishment of the Police Department of the Township of North Bergen is hereby recognized and said establishment is hereby declared to be in accordance with N.J.S.A. 40A:14-118.
- Section 2. The North Bergen Police Department is and shall be a Department within the Department of Public Safety in the government of the Township of North Bergen.
- Section 3. In accordance with the provisions of the Township of North Bergen's form of government, the Walsh Act, the "appropriate authority" for purposes of N.J.S.A. 40A:14-118 is the Director of the Department of Public Safety.
- Section 4. The North Bergen Police Department shall consist of one (1)
 Chief of Police, up to two (2) Deputy Chiefs of Police, up to three (3) Captains

of Police, up to ten (10) Lieutenants of Police, up to eighteen (18) Sergeants of Police, and no more than ninety (90) Patrol Officers.

Section 5. The Director of the Department of Public Safety shall be the appointing authority for all positions in the North Bergen Police Department and shall have authorization to set salaries for each position within the range of salaries authorized by the Township's Wage and Salary Ordinance.

Section 6. The Director of the Department of Public Safety shall also be the appointing authority for up to 12 positions authorized by the Special Law Enforcement Officers Act, N.J.S.A. 40A:14-146.8 et seq. as that law now exists or as it may be modified or amended from time to time by the New Jersey Legislature. The Director shall also have authority to set hourly wages for any such positions within the range authorized by Township ordinance.

Section 7. The Director of the Department of Public Safety is hereby authorized to adopt and promulgate rules and regulations for the government of the North Bergen Police Department and the discipline of its members.

Section 8. The Chief of Police shall be the head of the North Bergen Police Department and shall be directly responsible to the Director of the Department of Public Safety for the efficiency and routine day-to-day operations of the Police Department and he shall, pursuant to policies established by the Director of the Department of Public Safety:

- a. Administer and enforce rules and regulations and special emergency directives for the disposition and discipline of the department and its officers and personnel.
- b. Have, exercise, and discharge the functions, powers and duties of the department.
- c. Prescribe the duties and assignments of all subordinates and other personnel.

d. Delegate such of his authority as he may deem necessary for the efficient operation of the force to be exercised under his direction and

supervision.

e. Report at least monthly to the appropriate authority in such form as

shall be prescribed by such authority on the operation of the department during

the preceding month and make such other reports as may be requested by such

authority.

Section 9. All ordinances or parts of ordinances inconsistent with this

ordinance are hereby repealed as to the inconsistency thereof.

Section 10. If any part or parts of this ordinance are for any reason held

to be invalid, such holding shall not affect the validity of the remaining portions

of this ordinance.

Section 11. This ordinance shall take effect upon adoption and

publication as required by law.

WHEREAS, the Commissioners of the Township of North Bergen recognize that handicapped drivers face unique difficulties in the location of parking spaces; and

WHEREAS, the Commissioners of the Township of North Bergen have been empowered by N.J.S.A. 39:4-205 to restrict certain areas for handicapped parking; and

WHEREAS, Ordinance No. 503-93, Ordinance No. 1115-07 and Ordinance No. 40-10 establish the terms and conditions for handicapped spaces.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Township of North Bergen that:

Section 1: One restricted handicapped parking space be and hereby is established in front of the residence of Secundino Abreu of 1200 – 7th Street, Apt. # 1 and Robert J. Farley of 2008 – 47th Street, North Bergen, N.J. 07047.

Section 4: This ordinance shall remain in effect for two (2) years ending December 31st of the second year from its effective date at which point it will expire and be of no further force or effect unless it is renewed for a further two (2) year period by formal resolution of the Board of Commissioners in accordance with Ordinance Nos. 1115-07 and 40-10.

Section 5: Any person who commits a violation of this ordinance shall be subject to a fine of at least \$290.00 and up to 90 days of Community Service on such terms and in such form as the Municipal Court Judge deems appropriate or any combination thereof. A separate offense shall be deemed committed on each day during or on which the violation continues.

Section 6: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as to the inconsistency thereof.

Section 7: If any part or parts of this ordinance are for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this ordinance.

Section 8: This ordinance shall take effect upon adoption and publication as required by law.


